MOZAMBICAN IMMIGRATION LANDSCAPE

Mozambique has 'recently' enacted new immigration regulations (December 2014). Despite being in force, in practice these Regulations are not being applied as yet and the previous Act, dated September 2006, offers the relevant framework. This framework is still mostly in place.

### **MOZAMBIQUE - Immigration & Visa**

Entry to Mozambique is currently prohibited except for Mozambican nationals and foreign nationals with a valid residency visa for Mozambique. The Mozambican authorities have resumed the issuing of visas, with the exception of tourism visas which are still not being issued at this time. Visas issued before 1 April have been cancelled.
