Washington labor laws require an employer to pay overtime to employees, unless otherwise exempt, at the rate of 1½ times the employee’s regular rate of pay for all hours worked in excess of 40 hours in a workweek. Swaziland's Minimum Wage is the lowest amount a worker can be legally paid for his work. Most countries have a nation-wide minimum wage that all workers must be paid. Swaziland's minimum wage rate is 531.6 Swazi emalangeni a month for a domestic worker,420 emalangeni a month for an unskilled worker,and 600 emalangeni a month for a skilled worker.

Swaziland Minimum Wage - World Minimum Wage Rates 2020

The Bureau of Labor Law Compliance is responsible for the administration, education, and enforcement of labor laws including Prevailing Wage, Minimum Wage, Child and Seasonal Farm Labor, Equal Pay and Wage Collection, Apprenticeship and Training, and the enforcement of the Underground Utility Act.

Laws and Regulations Home - Department of Labor & Industry

(l) An employee who is required to be on duty and work in excess ofthe hours specified in Regulation 5 shall be entitled to be paid for such overtime at the rate ofone and a halftimes the employee's normal hourly rate of wages. Payment shall be calculated on the basis of the overtime worked each day in excess ofthe daily working hours.
